WHEN MAKING AN APPEARANCE AT A HEARING ON A PARKING OR MUNICIPAL CODE VIOLATION TICKET(S). YOU SHOULD BE AWARE OF THE FOLLOWING REQUIREMENTS:

- If you are not named in the summons, you must have notarized authorization to represent the defendant.
- You must have printed copies of all evidence and any witnesses you feel necessary to establish your case, in attendance at the time of your hearing.
- You may call our office and reschedule your hearing BEFORE your scheduled time if:
 - 1. You do not have your evidence or witnesses and need them for your case.
 - 2. You are unable to appear for your hearing as scheduled.
- You may be granted only one (1) reschedule.
- If you fail to appear for your original hearing or your rescheduled date and would like your case reopened, you will need to file a Motion to Vacate and pay a \$50 fee; approval is not guaranteed. : BTAG DMRASH GBJUGSHOS
- An adjournment will not be granted, in any case, for a later production of evidence or witnesses once the hearing begins, unless requested by the Hearing
- At your hearing, penalties may be assessed against you by the Hearing Examiner if:
 - 1. You are not prepared for a hearing.
 - 2. You do not request an adjournment after the hearing begins
 - 3. You entered a guilty plea within the required period of time
 - 4. You are found guilty.
